Review of IH Chapter 15 Financial Records For 2017

Dave Kanten, Treasurer MN IH Chapter 15 requested in January 2018 that I review the IH Chapter 15 Checking and Savings statements for the year 2017. I assumed that this was part of the plan as President Radil stated at the December membership meeting that there would be an audit of the financial transactions for 2017. The tasks I perform for this review do not constitute an audit. An audit would also involve checking the cash that the membership secretary and merchandise staff work with. I received from 2017 Chapter 15 Treasurer Dave Kanten a 2017 "IHCC Checking Listing", "Itemized Categories" and "Banking Summary" from the accounting records for the checking and savings accounts.

I am able to go on line at the Wells Fargo web site and view the Chapter 15 banking information as I have check signature authority for membership disbursements / expenses. I was able to view each deposit and check / disbursement shown on the bank state-

ment for the year 2017 as handled by the bank.

I reviewed most deposit and expenditure and compared the bank individual transactions against transactions recorded in the accounting detail listing. The following are my findings:

- The bank transactions and amounts agree with the detail transaction reports that the Treasurer has provided to Chapter leadership at appropriate times.
- 2. The Treasurer has provided bank balances in the Chapter Newsletters. The amounts shown in the Newsletters are appropriate numbers.
- 3. Every transaction seemed appropriate for the Chapter's business as it was conducted in 2017.
- It appears the Treasurer's aspect of the Club's financial transactions are properly maintained and controlled.

Based on the bank financial records review and personal experiences it appears the Chapter 15 Treasurer performed his tasks in a professional, organized and timely manner. He is doing all or more of what is expected to be performed for an organization such as MN IH Chapter 15.

Financial Analysis Comments

- 1. The club has \$327 more cash on hand on December 31 compared to January 1.
- 2. The club donated \$500 in March for 2016 to IHCC Trust and \$1,000 in Dec for 2017
- 3. The merchandise inventory decreased \$968 from the beginning to end of year.
- 4. Chapter 15 had a "breakeven year" in 2017 thanks to the leadership's effort.
